**Membership:** No applications at present, but Rich is talking with a couple people who have yet, to commit.

**Donations:** John reported \$24.82 from the website. This was after fees were deducted. To the O scale layout Ken donated 5 cars.

Old Business: None.

#### **New Business:**

- 1. John suggested donations be included in budget planning as a goal.
- 2. Mike suggested we keep and maintain a balance sheet. John made a motion of the suggestion and Steve offered a second. Voted for and approved.
- **3.** The Board approved an increase of \$5 for membership at every level. If approved, new members following approval of the increase. would be responsible for the increase. The increase would then be included in the 2023 dues. Marty made a motion that full member dues amount be \$70 (a \$10 dollar increase). Richard offered a second. Voted and approved. Mike made a motion to approve increasing the cost of membership, to which Marty did second the motion. Voted on and approved.

**HO:** Richard Turton reported "Much work has been done to get the roadbed and back ground done before the NMRA meeting." We may need to purchase more Masonite. Work days continue on Mondays and Wednesdays, but will change to one day a week (Monday). We need more cork roadbed. Keith made a motion that an additional \$500 be allocated for additional supplies. Rich made second and the motion was approved by vote. Ken commended the work crew on the advancement of work done.




